STEPS TO COMPLETE A COMMERCIAL BUSINESS LOCATION

All steps must be completed before a Local Business Tax Receipt can be issued.

- 1.) Fictitious Name, Incorporation and LLC:** Per Florida Statute 205.023 (1) The Fictitious Name must be filed with the State of Florida at www.sunbiz.org before we can issue a Business Tax Receipt. To avoid having to file for fictitious name a tax payer may use their first and last name as the business name if they wish.

- 2.) STATE LICENSE REQUIREMENTS:** When doing business in the state of Florida certain businesses are required to obtain a "State License". To find out if the type of business you are doing requires additional licensing, please click the links to find out which state department you will be required to contact.

- 3.) Zoning Department:** The location of the business and the use proposed must be approved. A **Change of Occupancy Form** must be completed. The form is available at the Charlotte County Zoning Department, located at: 18400 Murdock Circle, online at <http://charlottecountyfl.com/bcs/forms.asp>.

- 4.) IRS or Social Security Number** : Per Florida Statute 205.0535(6) a business tax may NOT be issued without one. Go to www.irs.gov for a Federal Tax ID Number.

- 5.) Business Tax Receipt:** The Tax Collector will issue a Business Tax Receipt for a commercial business location after all the above steps are completed. After a Business Tax Receipt is issued, it may be renewed online at <http://taxcollector.charlottecountyfl.gov>.

Building Construction Services

Contractor License Guide

Charlotte County Code Section 3-2-6 (a) requires that it shall be unlawful for any person to engage in the business or act in the capacity of a contractor, or advertise as available to engage in the business, or act in the capacity of a contractor, without first obtaining a Certificate of Competency or being duly certified by the state.

This guide has been developed to assist you in obtaining a Certificate of Competency (Contractor License) from Charlotte County.

To obtain a contractor license you are required to submit the following with your application:

Documentation of related experience, see back for number of years required. Documentation is to be on letterhead stationery from the employer(s), indicating the **exact dates of employment, type of work and duties performed, and must be notarized.**

- If you are applying for a license as an individual (legal first and last name) you only need the information above, otherwise you are required to submit the following with your application:
- **If you are applying for a license under a fictitious name**, provide a copy of the fictitious name recording that has been registered with the Secretary of State of Florida.
- **If the company is a corporation**, provide a copy of Certificate of Incorporation, minutes indicating current officers names and titles and a Resolution of Authorization (this states that the applicant is authorized to apply for a license to qualify the corporation).
- **If a partnership**, you will need to complete the Partnership Agreement Form.
- **Letters of reciprocity** are accepted from the county from which the exam was taken, stating exam date, type of exam, and grade received (75% or higher is required). Letters of reciprocity **must** include the number of years experience submitted by the applicant prior to taking the exam. Both trade and business, and law exams are required. The exam taken **MUST** be the same exam Charlotte County offers. **NO SUBSTITUTIONS ARE ALLOWED.**
- **Copy of current picture identification** such as a driver's license **with current home address shown.**
- **A credit report sent directly to this office from the credit bureau** on your personal credit and your business credit must be provided. If you are applying to change the company name, you will need a credit report on the old company name also.
- **A check for the application fees** made out to the Charlotte County Board of County Commission (CCBCC) for the licensing period. (Fees are listed in the table below.) Please call 941.743.1201 if you are unsure of the amount due. **This fee is non-refundable after the application is reviewed.**
- **A passport type photo** of yourself attached to the application.
- **An original certificate of insurance on worker's compensation** showing **Charlotte County Building Construction Services** as the certificate holder which indicates the insured's name, company name and address, and the policy number. If exempt, submit a copy of the approved worker's compensation exemption from the Department of Labor (State). Proof of insurance is not required until the application is approved. Certificate must be in the exact name of the business in which you are to qualify and must indicate that the qualifier is covered under the policy if this division is not also provided with a worker's compensation exemption for the qualifier.
- **An original certificate of insurance** stating general liability with limits of \$300,000 bodily injury and \$50,000 property damage or \$300,000 combined single limit liability (State Electrical Board limits are higher) showing **Charlotte County Building Construction Services** as the certificate holder which indicates the insured's name, company name and address, and the policy or binder number. Proof of insurance is not required until the application is approved. Certificate must be in the exact name of the business in which you are to qualify.

- **Copy of current active state registration license** is required for the following trades: General, Building, Residential Contractor, Master Electrician, Master Plumber, Air Conditioning (A,B,C), Mechanical, Swim Pool (A,B,C), Roofing, Sheet Metal, Underground Utility, or Solar Energy. **If you do not currently hold a state registration for the above categories**, once the license has been issued by the county, the applicant **must** register with the Department of Business & Professional Regulations and provide Charlotte County Building Construction Services Department with a copy of the state registered license **prior to conducting business**.
