A renewal card will be mailed by June 30 to update your business tax receipt for the current year. Your local business tax receipt has been modified beginning in 2009/2010 from prior years. An example of the current receipt is as displayed below.

The top portion of the receipt is for your records. The middle portion of the receipt is your copy to be displayed in your place of business.
